- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 1. Experience Certificate for the supply of the same to any Govt/ PSU/ any renowned private organisation along with Supply/ Purchase Order.

2. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

3. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

4. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

6. Service & Support

10. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. The Security Agency must ensure the provisions of Private Security Agency Central Model Rules 2020 no tified by Ministry of Home Affairs, Gol dated 15.12.2020. The bidder should have Private Security Agency R egulation Act (PSARA), license Madhya Pradesh.
- 2. The Contractor shall not engage any sub-contractor or transfer the contract to any other person/ party.
- 3. The assessed number of security personnel required to be engaged will be 18 Security Guards. However, Director, ICMR-NIREH, Bhopal shall have the right for increase/ decrease the same, as per GeM n orms.
- 4. Police clearance regarding verification of character & antecedents of persons deployed will be obtained/produced by the contractor before deployment of such personnel.
- 5. The bio-data together with color recent photographs of all security persons proposed to be deployed should be furnished to the Institute at the time of acceptance of the contract award.
- 6. A copy of the original acquaintance rolls for payment of wages may be furnished by the Contractor alon g with succeeding month's bills.
- 7. The security deposit shall be returnable to the agency after expiry of the contract on furnishing usual clearance/no demand certificate.
- 8. In case, the Contractor fails to execute the job after entering into the CONTRACT AGREEMENT OR leave t he job before completion of the period of contract at their own, the Director, ICMR-NIREH, Bhopal shall hav e right to forfeit the security deposit.
- 9. The contract can be terminated by giving one month's notice by ICMR-NIREH, Bhopal and two month's notice by the agency.
- 10. In case of any loss or theft, it shall be made good by the Contractor. In the event of failure on their part to do so within a period of one month, the loss shall be made good by encashment of security deposit. If t he amount of loss or damage exceeds the amount of security deposit, then the balance amount shall be re covered straightway from the dues payable to the Contractor.
- 11. The Contractor shall comply with relevant provisions under the Labour Laws of State/Central Govt. and the Council shall not be responsible for any default/violation of the same on the part of the Contractor.
- 12. Bid offering service charges of less than 3.85% will be rejected. Only service charge in % up to two decimal to be quoted by the service provider.
- 13. Providing uniforms and payment of washing allowance to the workmen will be at the cost of the contra ctor. No separate charges on this account should be included in the above schedule of rates as the same is to be borne by the contractor.
- 14. The office/ branch/ site office of the service provider must be located in Bhopal, MP.
- 15. (a) Bank statement indicating payment made to individual manpower to be provided along with each i nvoice. (b) No payment shall be made in advance nor any loan from any bank or financial institution recommended on the basis of the order of award of work. (c) The contractor shall pay to the employee before the expiry of the seventh day of the following month and raise invoice to buyer (ICMR-NIREH, Bhopal) after releasing the payment to manpower. (d) Each monthly bill must accompany the copies of authenticated documents of payment of such contributions of EPFO/ESIC. (e) Overtime will be admissible only when hired staff works for more than 26 days in a month.
- 16. Bidders may note that the following are attached separately and uploaded in the Buyer Uploaded ATC documents that are mandatory to be submitted at the bid stage strictly as per the prescribed format:
- (a) Undertaking by the bidder(s)
- (b) Proforma for declaration on court receivership/ liquidation/ blacklisted

- 17. In addition to above, bidders are also required to submit the following documents:

- (f) For Minimum Average Annual Turnover of the bidder (For 3 Years): Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant/ Cost Accountant indicating the turnover details for the relevant period
- (g) For Years of Past Experience required for same/similar service: Copies of relevant contracts/ orders for providing similar type of services to any Central/ State Govt. Organization/ PSU and documentary evidence of successful execution / completion in support of Past Experience of Similar Services during each of the Fi nancial year.
- 18. The successful bidder shall furnish the performance security for an amount equal to 3% of bid amount in terms of Bank guarantee of any nationalized bank within 15 calendar days from the date of acceptance of the bid which should be valid upto 14 months from the date of issue of BG. The bidder has to extend the validity of the BG upto the extended period also at his own cost.

19. PAYMENT TERMS

- 19.1 Payment Condition: (a) The cost of services quoted by the Service Provider shall be cover all aspects of service delivery and include all the components of salary/ wages (minimum wage, insurance, PF, ESI, etc) bonus, uniform, as applicable. (b) The Payment shall be made as per the financial quotes submitted by the Service Provider and accepted by the Buyer.
- 19.2 Payment Cycle: (a) Payment shall be made once the services are delivered, and the Service Provider submits the invoice for the same. (b) The Buyer shall make the payment to the security personal within 7 d ays of succeeding month and submission of invoice, logbook and service feedback.
- 19.3 Payment Process: (a) Payment shall be made only after submission of invoices, attendance sheet, log book, service feedback, non-submission of the same may lead to delay/ deduction in payment.
- (b) All the penalties/ fine/ interest (if applicable) shall be settled before making the payments. Service Provider shall not have any objection on the same.
- (c) Payment shall be made through bank transfer only, in no circumstance cash/ cheque payment shall be made.
- 20. Wages and all statutory compliance are to be paid as per the latest order issued by the concerned Dep artment in this regard.
- 21. Following bidder(s) will be exempted from the criteria of Minimum Average Annual Turnover and Years of Past Experience:
- (a) Micro and Small Enterprises who are Service Provider (Major Activity as Services) of the Primary Service Category and whose credentials are validated online through Udyam Registration/ Udyog Aadhaar website.
- (b) Start-ups as recognized by Department of Industrial Policy and Promotion (DIPP).

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्ते</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
