If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. ### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

### 2. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

### 3. **Service & Support**

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

### 4. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 5. **Forms of EMD and PBG**

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of

. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

### 6. **Forms of EMD and PBG**

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

A/C (Name of the Seller). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original FDR to the Buyer within 15 days of award of contract.

### 7. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. Bid offering service charges of less than 3.85% (incl GST) will be rejected. ICMR-NIREH, Bhopal will not entertain any representation/ justification submitted by the bidders in this regard at the financial evaluation stage.
2. It is the responsibility of the bidder to provide manpower as per Buyer's requirement. Age, education qualification and experience of the person deployed should be as per the eligibility criteria for the respective post.
3. In case of breach of any of T&C, the Director, ICMR-NIREH, Bhopal will have the right to cancel the contract without assigning any reason thereof, and the Performance Security deposit shall be encashed.
4. The bidder should submit only one bid in the tender process. Bidder submitting more than one bid i.e. 02 bidders having controlling partners in common will result in the disqualification of all the concerned bids.
5. The agency should not have been declared on court receivership/ liquidation/ blacklisted/ banned/ debarred by any Central/ State Govt Organization/ PSU. An undertaking (as per Annexure B of the Buyer Uploaded ATC document) issued after the date of tender publication shall be furnished by the applicant.
6. The office/ branch/ site office of the service provider must be located in Bhopal.
7. Additional manpower to be provided as per requirement within 1 week.
8. The consent of ICMR-NIREH is necessary before removing any manpower.
9. Only service charge in % up to two decimal to be quoted by the service provider.
10. (a) Bank statement indicating payment made to individual manpower to be provided along with each invoice. (b) No payment shall be made in advance nor any loan from any bank or financial institution recommended on the basis of the order of award of work. (c) The contractor shall pay to the employee before the expiry of the seventh day of the following month and raise invoice to buyer. (d) Each monthly bill must accompany the copies of authenticated documents of payment.
11. Bidder to note that there shall be no requirement of paying EMD against this tender. However, all bidders

The requirement of submission of Bid Security de claration shall also be applicable on bidders who are exempted from payment of EMD (MSME and Startups) 12. The successful bidder shall furnish the Performance Security for an amount equal to 4% of bid amount within 15 calendar days from the date of award of the contract. The bidder has to extend the validity of the PBG upto the extended period also at his own cost. In case of non-receipt of Performance Security within 1 5 days, Contract may be cancelled.

13. The payment to the Service Provider will be made directly by the ICMR-NIREH.

14. Any Addendum/ Corrigendum/ Bid End Date Extension in respect of the tender shall be issued on GeM portal and ICMR-NIREH website only.

15. The sole jurisdiction over any matters arising in connection with any actions or proceedings arising out of or in relation to this tender and subsequent contract shall be with the Courts of Bhopal only.

16. Bidders may note that the following are attached separately and uploaded in the Buyer Uploaded ATC documents that are mandatory to be submitted at the bid stage strictly as per the prescribed format:

17. In addition to above, bidders are also required to submit the following documents:

18. Following bidder(s) will be exempted from the criteria of Minimum Average Annual Turnover and Years of Past Experience: (a) Micro and Small Enterprises who are Service Provider (Major Activity as Services) of the Primary Service Category and whose credentials are validated online through Udyam Registration/ Udy og Aadhaar website. (b) Start-ups as recognized by Department of Industrial Policy and Promotion (DIPP).

19. In case of any revision in rate of Basic Wages and statutory contribution during the contract period, the contractor shall be compensated for the additional implication arising out of the revision, based on proof of payment to the contract manpower by the contractor to establish the differential implication.

20. All the manpower outsourced to ICMR-NIREH shall wear Identity Card provided by the Service Provider every day during working hours.

21. PENALTY: (a) In case of delay in payment of salary for a month beyond due date i.e. 7th of the succeed ing month: Rs.1000 per person per day

(b) In case, the specified number of manpower is not deployed due to any reason / there is any absenteeis m on the part of workmen assigned for the jobs on work timing and the contractor fails to provide a replace ment: Rs. 500 per person per day

(c) If any person employed by the contractor does not wear his/ her identity card during the duty period: R s. 200 per person per day

22. The successful bidder will furnish complete details of his employees prior to deployment such as reside ntial address, pass port size photo, ID proof and contact No.

### 23. PAYMENT TERMS

23.1 Payment Condition: (a) The cost of services quoted by the Service Provider shall be cover all aspects of service delivery and include all the components of salary/ wages and taxes, as applicable. (b) The Paym ent shall be made as per the financial quotes submitted by the Service Provider and accepted by the Buye r.

23.2 Payment Cycle: (a) Payment shall be made once the services are delivered, and the Service Provider submits the invoice for the same. (b) The Buyer shall make the payment within prescribed timelines as per the payment process flow upon submission of invoice, logbook and service feedback.

23.3 Payment Process: (a) Payment shall be made only after submission of invoices, bio-metric attendanc e sheet, logbook, service feedback, non-submission of the same may lead to delay/ deduction in payment. (b) All the penalties / fine/ interest (if applicable) shall be settled before making the payments. Service Pro vider shall not have any object ion on the same. (c) Payment shall be made through bank transfer only, in no circumstance cash/ cheque payment shall be made.

24. The bidder should have financial standing to pay atleast 02 months wages to all the manpower provided to ICMR-NIREH. In case of delay in making payment to the bidder due to clarification/ shortage of document, the bidder should make payment to manpower provided timely as per the tender condition.

25. Services of the bidder may be reviewed after a period of 01 year of the contract. Service will be continued for the next 01 year of the contract only in case of satisfactory performance of the bidder.

26. In case of any discrepancy, Buyer Added text based ATC and Scope of Work shall prevail over Bid Details, Technical Specification and GTC.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.

**The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:**

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

**All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.**
