2. The quotation is to be submitted only in the format enclosed. Not acceptable in any other form.
3. The bidder should clearly mention whether they are Manufacturer or authorized Dealer/ Agent/ Distributers/ Suppliers of the Manufacturer. In the case of Dealer/ Agent/ Distributers/Suppliers, valid authorization letter from the Manufacturer address to Director, ICMR-NIREH, Bhopal should be submitted along with the quotation. One manufacturer can authorize only one agent/ dealer.
4. Quotation received after the last date & time is liable to be rejected.
5. GST will be applicable as per Gol norms to ICMR-NIREH, Bhopal.
