Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

7. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

Buyer Added text based ATC clauses

1. Scope of work will include taking of empty cylinders from ICMR-NIREH, refilling of gases in the cylinders and transportation of filled cylinders to the Institute. Loading, transport and unloading are under the scope of contract. The vendor shall arrange transport facilities for the transportation of gas cylinders. Cylinders to be refilled under this contract are buyer-owned cylinders. Quoted cost shall cover refilling, associated transportation/ loading/ unloading/ handling charges and applicable taxes.
2. Gas cylinders are to be refilled on "as and when requirement basis" for a period of 12 months.
3. It shall be the sole responsibility of the vendor to follow the relevant gas cylinder rules while transporting the filled gas cylinders to ICMR-NIREH and taking back the empty cylinders from ICMR-NIREH to their premises. It shall also be the sole responsibility of the supplier/ vendor for holding and maintaining relevant explosive license (wherever required).
4. The quantity of cylinders mentioned in inquiry is indicative only. It can be less or more than the indicative figure depending upon ICMR-NIREH requirement.
5. The bidder should have operational local warehouse and office in Bhopal to facilitate routine liaisons and recurrent operational replenishments without delay within specified time limits.
6. Refilled Cylinder condition should be healthy on receipt, if any leakage/ damage will be observed, vendor has to take back the cylinder at his own cost and replace with the new one. No charges will be borne by ICMR-NIREH.
7. LD clause: If bidder failed to refill the cylinder within the stipulated delivery period of 07 days, L.D. will be imposed at 0.5% per week of the amount of refilling that particular cylinder, if supply made after expiry of due date subject to maximum 10% of the total value of refilling that cylinder.
8. Payment Terms: Payment shall be made on a monthly basis upon submission of the invoice and delivery challan for the refilled gas cylinders, subject to satisfactory verification and certification by the indenting official of the Institute. 9. Service Provider shall submit separate invoices for each project. Each invoice shall clearly indicate the respective project name. Project name and corresponding budget head shall be communicated separately by ICMR-NIREH at the time of placing the service requirement.
10. In case of emergency and non-responsiveness from the vendor, ICMR-NIREH may refill the gas cylinder through separate contract with a new supplier.
11. ICMR-NIREH reserves the right to terminate the contract at any time, without assigning any reason whatsoever, including but not limited to cases of repeated delays in supply, substandard gas purity, safety violations, or non-compliance with the terms and conditions of the contract.
12. Service Provider shall depute a dedicated contact person/ representative for coordination and timely resolution of all service-related matters pertaining to ICMR-NIREH throughout the contract period.
13. Conditional bids, submission of the financial bid or any price-related information as part of the technical bid and failure to submit the mandatory documents as specified in the tender shall result in outright rejection of the bid and disqualification of the bidder.
14. The details/ specifications of the respective gases mentioned in the attached Scope of Work shall prevail.
